I understand that I am authorized to purchase up to a six-month supply of the NATM Compliance Decals signifying my trailers have been manufactured pursuant to a process designed to build motor vehicles in accordance with specific NATM *Guidelines*. If I manufacture trailers intended only for off-road use or any other product expressly exempt from the NATM Guidelines Compliance Program, I understand that I must not put any NATM Compliance Decal on that trailer or product. I further certify that I will promptly return and re-sell all unused decals to NATM in the event (1) there is any change in the ownership or control of my company; (2) my company is subsequently determined not to be in compliance with the NATM *Guidelines* following a compliance consultation; or (3) my company fails to renew its annual membership.
